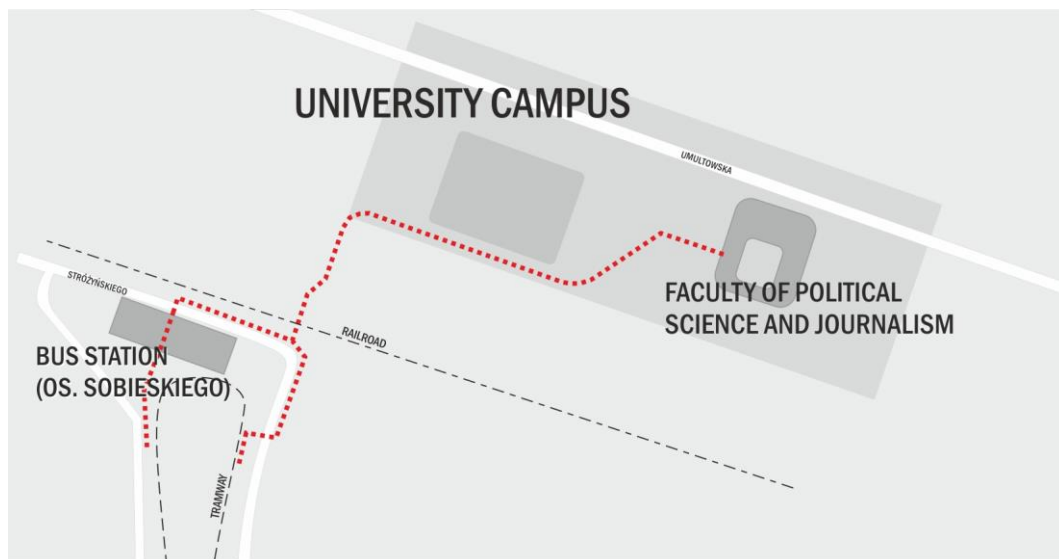
Getting there by car
